Mark June 28. Mark it well.

Taxes



The best way to control a man is to control his money.

As much of it as possible.

The NDP's ultimate goal of State ownership/State control has given Manitobans the highest corporation tax in Canada.

The highest individual income tax.

The highest death tax.

And the promise — voiced by NDP members in the Legislature last year — that they believe in "virtual confiscation" of everything a man has accumulated during his lifetime, when he dies.

June 28, you and your fellow-Manitobans will be asked to decide whether you're willing to be taxed to death — and beyond it — by a government that has to own to control, or whether you prefer to live under the Asper/Liberals incentive system.

The self control system that lets you keep more of what you earn because it trusts you to handle your own money.

The self control system that says lowering taxes lowers the cost-of-living — and bases that statement on the solid reasoning of nationally recognized tax expert Izzy Asper.

The self control system that feels frankly that you can look after yourself, better, if a Big Brother bureaucracy hasn't got its hand in your pocket from cradle to grave.

Izzy Asper and his Manitoba Liberals are making just eight election promises.

One of them is to tax only as much as a self controlled society has to — lowering some taxes and eliminating others.

And here are a few of the changes they plan to make.

You shouldn't be taxed to death on the necessities of life.



Immediate end of sales tax on all of the necessities of life: food, clothing, housing, home repairs, hydro, heating, telephone, and used goods — such as a second-hand car or furniture.

Reduction of sales tax on everything else by 40% — from 5% to 3% — and start of a program for complete removal of all sales tax. This most regressive and unfair of all taxes, introduced to Manitoba by the Conservatives, taxes those on fixed, low and middle incomes equally as much as it taxes those most able to afford to pay it. In this way at the very least, it is an unjust form of taxation.

Removal of school taxes from farms, homes and rental paid on apartments. This means that if an apartment dweller is paying \$150 a month rent, and \$35 goes toward his landlord's property tax, about \$18 a month is school tax. The Asper/Liberals plan would save this apartment dweller about \$200 a year.

Immediate 10% cut in personal income tax. Asper/Liberals believe that the more earned dollars a man gets to keep, the more incentive he has to earn. This makes for a more robust economy for all Manitobans.

Jobs

No matter how the NDP tries to cut it, unemployment in Manitoba has gone from bad to worse over the past four years.

None of us wants to be a prophet of doom — it's not a Manitoban's nature — but the fact is that fully twice as many people are out of work.

Our increase in unemployment is double the national average.

As you read this, 18,000 of your fellow-Manitobans are looking for jobs. 10,000 unemployed Indians and Metis are not included in that figure. 5,000 people are busy working — at re-training programs. Several thousand more are listed as "employed" because they're working on some government-paid "make-work" project. 29,000 other people received welfare last year. 10,000 others simply packed up and left the province.

The seriousness of this job shortage, and its effect on all of us in Manitoba, is staggering.

Izzy Asper and his Liberals are making just eight election promises.

One of them is to create 50,000 new jobs — right now.

And here are a few of the ways they intend to do it.

Leaving Manitoba shouldn't be the only way to find a job.



50% cut in provincial corporation tax for manufacturers and processors locating in rural or northern Manitoba. For all Manitoba manufacturers and processors, a 50% tax cut on profits made on out-of-province sales of made-in-Manitoba goods. Both these tax cuts would provide strong incentive for new industry to move here.

Establishment of a system of grants, loans and further tax incentives, as Ontario has been doing for years, so that Manitoba can compete more effectively with other parts of Canada in attracting new industry.

Expansion of tourism facilities and promotion, estimated to be capable of producing 30,000 new jobs.

Creation of Manitoba as Canada's major financial centre by establishment of a provincial capital gains tax rebate system. Expected to attract many financial institutions to Manitoba, this would create many new jobs at all levels on the Winnipeg Stock Exchange.

Launching of a full-scale resource exploration program to inventory all major deposits of mineral wealth in Manitoba. Development of these deposits by private industry would result in thousands of new jobs.

Establishment of Manitoba Trade Offices in major cities throughout the world — to promote tourism, export sales, and to attract new industry to Manitoba.

And finally, to get the Manitoba Government out of the many businesses it has gotten into under the NDP. To give business back to the businessmen, and to let government get back to the full-time business of running the government well.

Senior Citizens



Old people shouldn't be made to feel like hangers-on.

If there is a priority in the eight election promises made by Izzy Asper and his Manitoba Liberals, it is to recognize in concrete terms the great contribution made to this province by its Senior Citizens.

Manitoba's Senior Citizens don't hold rallies.

They don't carry placards — or raise their voices in protest.

But most of these 100,000 men and women do suffer neglect and injustice.

This forgotten minority suffers the indignity of being all but ignored by the society they helped build.

As already stated, Izzy Asper and his Liberals are making just eight election promises.

One of them is to set up, immediately, a fair deal for Manitoba's Senior Citizens.

And here are some of the ways they intend to do it.



Introduction of a pension supplement for low-income Senior Citizens. This supplement would guarantee each single pensioner \$200 a month—or \$400 for married couples who require income supplement. It would not be a universal program, but would be aimed at those who are in need of it. It would also apply to the physically or mentally handicapped who are unable to work. Under the Canada Assistance Plan, it is expected that the Federal Government will pay 40% or more of the plan's cost.

Abolition of provincial income tax for low-income Senior Citizens. Under this program — which the NDP repeatedly has refused to approve, each time it has been introduced by Liberals in the Legislature — any Senior Citizen earning less than \$3,000 will pay no provincial tax. Nor will married pensioners with income under \$4,500.

Extension of Medicare to include nursing home care when prescribed by a doctor, as well as the full cost of prescription drugs; spectacles; wheelchairs; vaccines; oxygen; dentures; and most other medically related needs of all those over 65.

Inclusion of the services of podiatrists (specialists in foot problems common to many elderly people) in Medicare.

Permanent removal of school tax from Senior Citizens' own homes and from the rent they pay on their apartments. This will assist those who own their own homes in maintaining them and generally lower Senior Citizens' cost of living.

Elimination of bus fares throughout the City of Winnipeg for all those over 65.

Farming

Izzy Asper, like many of his Manitoba Liberals, was born and raised in rural Manitoba.

For two years, as Liberal leader, he has hammered away at the problems of rural decline and depopulation. It was he who first disclosed that one-third of Manitobans live in our rural communities — and half of these live below the poverty line, largely due to rising farm costs and changeable farm incomes.


It was he who first called for a rural sewer and water program, a progressive plan finally adopted by the NDP government. Asper/Liberals believe that appropriate industries should be decentralized from the overcrowded city into the rural areas. While at the same time, family farms should be preserved as a way of life, and young people should be encouraged to become first-time farmers.

Izzy Asper and his Liberals are making just eight election promises.

One of them is to build towards a strong rural community in Manitoba.

And these are some of the ways they intend to do it.

State farm takeovers make employees of farmers.



Creation of a financing plan to assist sons and daughters in buying the family farm from retiring parents — or for other young people to become first-time farmers. Interest and repayment would be based on return from the land in cash terms, rather than in production figures.

Relocation of the Department of Agriculture in a rural community. This would serve the double purpose of providing greater contact between the department and the people it is supposed to serve, and provide many new rural jobs.

Relocation of the Department of Municipal Affairs in a rural community. Again, this department is designed to serve our rural areas. Relocating it in a rural community makes good sense, creates many new jobs for our rural sons and daughters — and gives good example from government for decentralization by private industry.

Setting up of incentives for food processors to locate or relocate in rural Manitoba. Food processing belongs where the food is grown. Food processing jobs belong in our rural communities.

Creation of grants — such as industry now gets — for expansion or diversification on the farm. Farming is one of our most important industries. It should be given the same growth incentives and benefits as other industry.

Phasing out of long distance telephone charges for calls made within Manitoba and a start on installation of private rural lines.

The tax incentives for rural industrialization referred to under Taxes in a preceding section.

Welfare

Anyone who can see what is going on around us knows that over the past four years the NDP Government has made it more attractive not to work than to work.

At least for those who like a free ride.

Izzy Asper and his Liberals believe in fair, generous and humanitarian welfare for those who are truly in need, and for those unable to work because of mental or physical handicaps.

But the welfare bureaucracy built up by the NDP over the past four years is frightening.

In 1969, there were 18,000 welfare cases. By 1972 — just four years later — 29,000. Our welfare costs went from \$17 million to \$47 million, an increase of fully 173% in just those four years.

Those four NDP years.

Izzy Asper and his Liberals are making just eight election promises.

One of them is to put an end to welfare waste

And here are a few of the ways they intend to do it.

Welfare shouldn't mean you pay for people who won't work.

Creation of more than enough jobs to go around. How this will be done is detailed under Jobs in a preceding section. By handing any ablebodied person a welfare cheque instead of a pay cheque, we chip away at their dignity as we do wrong by the working taxpayer. With enough jobs to go around, there will be no excuse for the able-bodied man or woman to look to welfare for support.

Establishment of a provincial job bank. The Liberal Government would set up a number of genuine, contributing work projects — not just "makework" projects — for people between jobs or otherwise temporarily unemployed. Projects such as road building, mineral exploration, riverbank clean-up, tree planting, and so forth are examples. Anyone temporarily unemployed would be assigned to one of these provincial job bank projects. Until a permanent job was found, he or she would draw a pay cheque — not a welfare cheque. This is what able-bodied people want. This is what the people paying the welfare bill want. This is what Asper/Liberals want.

Setting up of a flexible minimum wage and government income supplement to make uneducated, unskilled, or handicapped people more employable — at the same time assuring them of the same high minimum wage, tied to the cost-of-living index, that Asper/Liberals plan for all Manitobans. Many men and women are on welfare because handicaps of one kind or another make it hard for them to find an employer who will pay them the minimum wage. By subsidizing these people, they are removed from the welfare roles — allowed to regain the personal dignity and satisfaction of contributing to the community.

Expansion of government assistance to self-help and citizen volunteer groups. Within these two kinds of groups lies the answer to how to get the government out of the welfare business — in the bureaucratic sense — so that more and more social services are run by the welfare recipients themselves, through self-help groups; and through citizen volunteers concerned with the problem. For example: day care centres for the children of working mothers — financially supported by government, but actually run by citizen agencies. All such social activities can be handled more efficiently, more economically, through self-help and citizen volunteer groups. In the long run, government aid to these groups will save the taxpayer money and more greatly benefit those who need our help.

Housing

Only in the rare, unguarded moment do they come right out and say it, but the fact is that the NDP believes in State control - State ownership — of everything.

This is why they are building thousands of apartment-homes and leasing them out to low-income

families.

The base basis the State

Such a system allows a lot of the undeserving, while

many of the deserving do without.

It denies countless lowincome Manitoba families the chance to own their own home; to own a piece of their own province.

Izzy Asper and his Liberals are making just eight election

One of them is to get lowincome Manitoba families into their own homes, and to help all Manitoba homeowners improve the homes they already have.

The offer to each Manitoban on low-income a grant of up to \$750 as down payment on his first home. Followed by a mortgage subsidy plan which will remain in effect until the purchaser's low-income reaches an average level. This plan would be paid for by the millions already being spent on State-owned and controlled apartment-homes by the NDP; by the healthy boost to the economy of province-wide new home construction; and by the additional income tax revenue from the thousands of new jobs created by this construction. The fact is, by taking full advantage of housing assistance programs already offered by the Federal Government, this plan could be carried out at no increase in cost to Manitobans.

Granting of a 5-year property tax exemption on the first \$2,500 any Manitoba homeowner spends on home improvements. This would encourage Manitobans to make their homes more livable, more attractive—rather than offering the discouragement of higher property taxes. Again, this plan would be paid for by the resulting boost to the economy; the additional revenue that goes with the creation of new jobs.

The North

One simple statement says it all.

For every \$1 the NDP government spends in Northern Manitoba, the people and industries of Northern Manitoba pay \$4 in taxes to Winnipeg.

That's why the North is isolated.

Undeveloped.

Exploited.

A Sleeping Giant who's been rolled.

Asper/Liberals believe in immediate and continuing northern development — at the same time making certain that northerners as well as southerners benefit fully from that development.

The feeling today among our ambitious, educated and skilled young people should be: Go North, young man — or young woman.

Instead, lack of opportunity and economic drawbacks like high transportation, communications and living costs have combined to put barriers up against northern development for all but a comparative few.

Izzy Asper and his Liberals are making just eight election promises.

One of them is intelligent development of the North.

And here are a few of the ways they intend to do it.

Immediate public rejection of the Kierans Report, which calls for government takeover of Manitoba's mining industry. Bureaucrats make unimaginative, unambitious developers, and even worse strawbosses. Imagine Manitoba's mining labor force having to bargain with an impersonal civil service management that doesn't have to show a profit; doesn't have to pay dividends; doesn't, in fact, have to do anything.

Construction of a roads network connecting northern communities to each other and to Southern Manitoba. This will not only aid resources development, but will open up a whole new tourism industry throughout the North.

Creation of a freight subsidy and tax incentive plan to attract new secondary industry to northern communities.



Establishment of a Northern Development Bank, directed by northern people who know the North and its potential, with head office in a northern community, to stimulate industrial growth.

Government departments of this type should be as close as possible to the people they are intended to serve. The jobs associated with these departments belong among the people they serve. Government should show good example to industry by doing its own decentralizing.
